

SENATE BILL No. 334

DIGEST OF INTRODUCED BILL

Citations Affected: None (noncode).

Synopsis: Tobacco sales enforcement. Prohibits the office of the attorney general and the division of mental health from entering or renewing a contract with the United States Food and Drug Administration to obtain state assistance in investigational coverage of retail establishments that sell tobacco products unless the contract meets the following conditions: (1) Minors used in investigations must be 15 or 16 years of age. (2) Undercover purchases must be limited to specific hours. (3) Minors who participate must be periodically photographed and provide a birth certificate. (4) Unannounced inspections may only be performed by the alcoholic beverages commission, state police, county sheriff, or the police of a municipal corporation.

Effective: Upon passage.

A BILL FOR AN ACT concerning health.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **The office of the**
- 2 **attorney general and the division of mental health may not enter**
- 3 **into or renew a contract with the United States Food and Drug**
- 4 **Administration to obtain state assistance in investigational**
- 5 **coverage of retail establishments that sell tobacco products unless**
- 6 **the contract meets the following requirements:**
- 7 (1) **Unless specifically required by the United States Food and**
- 8 **Drug Administration, a minor used in an unannounced**
- 9 **investigation of a retail establishment that sells tobacco**
- 10 **products must be at least fifteen (15) and less than seventeen**
- 11 **(17) years of age.**
- 12 (2) **Undercover purchases of tobacco products by minors may**
- 13 **only be made:**
- 14 (A) **between the hours of 3 p.m. and 6 p.m. on weekdays**
- 15 **during the school year; and**
- 16 (B) **during daylight hours on weekends and school vacation**
- 17 **days.**
- 18 (3) **That for each minor who is used to make undercover**

purchases of tobacco products:

(A) a picture of the minor must be taken:

(i) not more than thirty (30) days after consent has been obtained for the minor to participate in undercover purchases; and

(ii) every month after the initial picture that the minor is used to make undercover purchases; and

(B) a copy of the minor's birth certificate shall be kept in a confidential file that is maintained for the United States Food and Drug Administration.

(4) Unannounced inspections of retail establishments that sell tobacco products may be conducted only by an entity listed under IC 7.1-6-2-1.

(b) This SECTION expires June 30, 2001.

SECTION 2. An emergency is declared for this act.
