

HOUSE BILL No. 1101

DIGEST OF INTRODUCED BILL

Citations Affected: IC 24-5-20.

Synopsis: Cable television bills. Requires a bill for cable television service to show certain specified information about the bill. Provides that a cable television service customer has 17 days from the date of the postmark of the initial bill to pay the bill. Provides that a late payment charge for cable television service may not exceed 10% of the first \$3 of the bill plus 3% of the amount over \$3. Provides that a customer is not required to pay a bill that fails to meet the statutory requirements. Provides that a cable system operator may not collect or attempt to collect a bill that fails to meet the statutory requirements. Provides remedies to a customer against a cable system operator that collects or attempts to collect a bill that fails to meet the statutory requirements.

HOUSE BILL No. 1101

A BILL FOR AN ACT to amend the Indiana Code concerning trade regulations and consumer sales and credit.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 24-5-20 IS ADDED TO THE INDIANA CODE AS
2 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 1998]:
4 **Chapter 20. Cable Television Bills**
5 **Sec. 1. As used in this chapter, "bill" refers to a bill for cable**
6 **television service.**
7 **Sec. 2. As used in this chapter, "cable system operator" has the**
8 **meaning set forth in 47 CFR 76.5.**
9 **Sec. 3. As used in this chapter, "customer" refers to a person**
10 **who receives cable television service from a cable system operator.**
11 **Sec. 4. A bill rendered periodically by a cable system operator**
12 **to a customer must show at least the following information:**
13 (1) **The amount of the bill.**
14 (2) **The previous balance, if any.**
15 (3) **The sum of the amount of the bill and the late payment**
16 **charge.**
17 (4) **The date when the bill becomes delinquent and the date**

1 the late payment charge will be added to the bill.

2 (5) Printed statements or actual figures, or both, on either side
3 of the bill must inform the customer of the seventeen (17) day
4 nonpenalty period.

5 Sec. 5. A bill must be issued as a net bill.

6 Sec. 6. (a) A bill is considered delinquent unless payment is
7 received within seventeen (17) days after the initial bill is
8 postmarked.

9 (b) A delinquent bill may be assessed a late payment charge.

10 (c) A late payment charge may not exceed ten percent (10%) of
11 the first three dollars (\$3) of the bill plus three percent (3%) of the
12 amount of the bill over three dollars (\$3).

13 Sec. 7. A customer is not required to pay a bill that does not
14 meet the requirements of this chapter.

15 Sec. 8. A cable system operator may not collect, or attempt to
16 collect, a bill that does not meet the requirements of this chapter,
17 through judicial process or otherwise.

18 Sec. 9. (a) It is a defense to an action by a cable system operator
19 to collect a bill from a customer for cable television service that the
20 bill violates this chapter.

21 (b) A customer may bring an action against a cable system
22 operator that violates section 8 of this chapter in a court with
23 jurisdiction for the following:

24 (1) An action to enjoin the cable system operator from
25 collecting the bill that violates this chapter and from further
26 violations of this chapter.

27 (2) An action for recovery of the person's actual damages
28 resulting from the violation of this chapter, including court
29 costs and attorney's fees.
