

HOUSE BILL No. 1117

DIGEST OF INTRODUCED BILL

Citations Affected: IC 2-3-1-1; IC 2-3-1-1.5.

Synopsis: Budget year special sessions. Provides that the annual salary of a member of the general assembly shall be reduced by \$100 for each calendar day that the general assembly is in special session to enact a budget bill. Provides that the deduction from the annual salary is made during the calendar year following the year of a budget special session. Provides that the deduction does not apply to an individual who was not a member of the general assembly during the budget special session or to an individual who was a member of the general assembly during the budget special session but is not a member of the general assembly during the following calendar year.

HOUSE BILL No. 1117

A BILL FOR AN ACT to amend the Indiana Code concerning the general assembly.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 2-3-1-1 IS AMENDED TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 1998]: Sec. 1. **Except as provided in section**
3 **1.5 of this chapter**, the annual salary of the members of the general
4 assembly shall be eleven thousand six hundred dollars (\$11,600).
5 One-half (1/2) the annual salary shall be paid on the fifteenth day of
6 January, and one-half (1/2) the annual salary shall be paid on the
7 fifteenth day of February.

8 SECTION 2. IC 2-3-1-1.5 IS ADDED TO THE INDIANA CODE
9 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY
10 1, 1998]: **Sec. 1.5. (a) This section applies as follows:**

11 (1) **This section applies if the general assembly convenes in a**
12 **special session during which a budget bill is introduced.**
13 (2) **This section applies to an individual who was a member of**
14 **the general assembly during a special session described in**
15 **subdivision (1).**
16 (3) **This section does not apply to an individual who is not a**
17 **member of the general assembly during the year following a**

- 2 (b) As used in this section, "budget bill" has the meaning set
- 3 forth in IC 4-12-1-1.
- 4 (c) For purposes of this section, the length of a special session is
- 5 the number of calendar days:
- 6 (1) beginning the day the special session convenes; and
- 7 (2) ending the day the special session adjourns sine die.
- 8 (d) The annual salary of a member of the general assembly for
- 9 the year following a special session described in subsection (a)(1)
- 10 is determined under the following formula:
- 11 **STEP ONE:** Determine the length of a special session
- 12 described in subsection (a)(1). If the general assembly
- 13 convened in more than one (1) special session described in
- 14 subsection (a)(1), add the length of each special session to
- 15 make the determination under this STEP.
- 16 **STEP TWO:** Multiply the number determined under STEP
- 17 ONE by \$100.
- 18 **STEP THREE:** Subtract the product determined under STEP
- 19 TWO from the salary prescribed by section 1 of this chapter.
- 20 (e) One-half (1/2) the annual salary prescribed by this section
- 21 shall be paid on the fifteenth day of January, and one-half (1/2) the
- 22 annual salary shall be paid on the fifteenth day of February.
