DIGEST OF INTRODUCED BILL

Citations Affected: IC 12-17.2-2-8; IC 12-17.2-5-1.

Synopsis: Child care home licensing exemption. Exempts from licensure a child care home that provides care to more than six children, not including children for whom the provider is a parent, stepparent, guardian, custodian, or other relative, if the provider obtains a written, notarized statement from a parent, guardian, or custodian seeking care for a child within the child care home. Requires the notarized statement to acknowledge the number of children for whom the child care home provides care and indicate the parent, guardian, or custodian's agreement to place the child in the provider's care under the circumstances. Requires the child care home to maintain records of the notarized statements. Requires the child care home to comply with

certain health, sanitation, fire, and safety rules approved by the division of family and children. (Current law requires a child care home that provides care to more than six children, not including children for whom the child care home provider is a parent, stepparent, guardian, custodian, or other relative, to be licensed.)

HOUSE BILL No. 1134

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 12-17.2-2-8, AS AMENDED BY P.L.2-1995,
2 SECTION 50, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 1998]: Sec. 8. The division shall exempt from licensure the
4 following programs:
5 (1) A program for children enrolled in grades kindergarten
6 through 12 that is operated by the department of education or a
7 public or private school.
8 (2) A program for children who become at least three (3) years of
9 age as of December 1 of a particular school year (as defined in
10 IC 20-10.1-2-1) that is operated by the department of education
11 or a public or private school.
12 (3) A nonresidential program for a child that provides child care
13 for less than four (4) hours a day.
14 (4) A recreation program for children that operates for not more
15 than ninety (90) days in a calendar year.



- 1 (5) A program whose primary purpose is to provide social,
 2 recreational, or religious activities for school age children, such
 3 as scouting, boys club, girls club, sports, or the arts.
 4 (6) A program operated to serve migrant children that:
 5 (A) provides services for children from migrant worker
 6 families; and
 7 (B) is operated during a single period of less than one hundred
 8 twenty (120) consecutive days during a calendar year.
 9 (7) A child care ministry registered under IC 12-17.2-6.
 10 (8) A child care home if the provider:
 11 (A) does not receive regular compensation;
 12 (B) cares only for children who are related to the provider;
 13 (C) cares for less than six (6) children, not including children
 14 for whom the provider is a parent, stepparent, guardian,
 15 custodian, or other relative;
 16 **(D) cares for more than six (6) children, not including**
 17 **children for whom the provider is a parent, stepparent,**
 18 **guardian, custodian, or other relative and:**
 19 **(i) informs a parent, guardian, or custodian who seeks to**
 20 **place a child in the provider's care that the child care**
 21 **home is unlicensed and discloses the number of children**
 22 **who are being cared for within the child care home;**
 23 **(ii) obtains a written, notarized statement from the**
 24 **parent, guardian, or custodian that acknowledges the**
 25 **number of children for whom the child care home**
 26 **provides care and indicates that the parent, guardian, or**
 27 **custodian agrees to place the child in the provider's care**
 28 **under the circumstances described in item (i);**
 29 **(iii) maintains records of statements obtained under item**
 30 **(ii);**
 31 **(iv) complies with health, safety, and sanitation**
 32 **standards as determined by the division under**
 33 **IC 12-17.2-2-4 for child care homes or in accordance**
 34 **with a variance or waiver of a rule governing child care**
 35 **homes approved by the division under IC 12-17.2-2-10;**
 36 **and**
 37 **(v) complies with fire and safety rules adopted by the**
 38 **division under IC 12-17.2-2-4 for child care homes or in**
 39 **accordance with a variance or waiver of a rule governing**
 40 **child care homes approved by the division under**
 41 **IC 12-17.2-2-10; or**
 42 ~~(D)~~ (E) operates to serve migrant children.

15 SECTION 2. IC 12-17.2-5-1 IS AMENDED TO READ AS
 16 FOLLOWS [EFFECTIVE JULY 1, 1998]: Sec. 1. (a) **Except as**
 17 **provided by IC 12-17.2-2-8**, a person may not operate a child care
 18 home without a license issued under this article.

19 (b) The state or a political subdivision of the state may not operate
 20 a child care home without a license issued under this article.

- 21 (c) A person may not operate a child care home if:
- 22 (1) the number of children maintained on the premises at any one
- 23 (1) time is greater than the number authorized by the license; and
- 24 (2) the children are maintained in a building or place not
- 25 designated by the license.
