

HOUSE BILL No. 1178

DIGEST OF INTRODUCED BILL

Citations Affected: IC 33-19-7-4.

Synopsis: Distribution of court fees. Makes the following changes to the distribution of criminal costs fees, infraction or ordinance violation costs fees, civil costs fees, small claims costs fees, and deferred prosecution fees: (1) Reduces from 55% to 45% the percentage of the fees that the clerk of a city or town court semiannually distributes to the auditor of state as the state share. (2) Increases from 25% to 35% the percentage of the fees that the city or town fiscal officer retains as the city or town share.

Effective: July 1, 1998.

HOUSE BILL No. 1178

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 33-19-7-4, AS AMENDED BY P.L.209-1996,
- 2 SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 3 JULY 1, 1998]: Sec. 4. (a) The clerk of a city or town court shall
- 4 semiannually distribute to the auditor of state as the state share for
- 5 deposit in the state general fund ~~fifty-five~~ **forty-five** percent (~~55%~~)
- 6 **(45%)** of the amount of fees collected under the following:
- 7 (1) IC 33-19-5-1(a) (criminal costs fees).
- 8 (2) IC 33-19-5-2(a) (infraction or ordinance violation costs fees).
- 9 (3) IC 33-19-5-4(a) (civil costs fees).
- 10 (4) IC 33-19-5-5 (small claims costs fees).
- 11 (5) IC 33-19-6-16.2 (deferred prosecution fees).
- 12 (b) Once each month the city or town fiscal officer shall distribute
- 13 to the county auditor as the county share twenty percent (20%) of the
- 14 amount of fees collected under the following:
- 15 (1) IC 33-19-5-1(a) (criminal costs fees).
- 16 (2) IC 33-19-5-2(a) (infraction or ordinance violation costs fees).

- 16 IC 33-19-5-1(b)(5).
- 17 (2) Twenty-five percent (25%) of the alcohol and drug
- 18 countermeasures fees collected under IC 33-19-5-1(b)(6),
- 19 IC 33-19-5-2(b)(4), and IC 33-19-5-3(b)(5).
- 20 (3) One hundred percent (100%) of the highway work zone fees
- 21 collected under IC 33-19-5-1(b)(9) and IC 33-19-5-2(b)(5).
- 22 (4) One hundred percent (100%) of the safe schools fee collected
- 23 under IC 33-19-6-16.3.
- 24 (e) The clerk of a city or town court shall monthly distribute to the
- 25 county auditor the following:
- 26 (1) Seventy-five percent (75%) of the drug abuse, prosecution,
- 27 interdiction, and corrections fees collected under
- 28 IC 33-19-5-1(b)(5).
- 29 (2) Seventy-five percent (75%) of the alcohol and drug
- 30 countermeasures fees collected under IC 33-19-5-1(b)(6),
- 31 IC 33-19-5-2(b)(4), and IC 33-19-5-3(b)(5).
- 32 The county auditor shall deposit fees distributed by a clerk under this
- 33 subsection into the county drug free community fund established under
- 34 IC 5-2-11.
