

HOUSE BILL No. 1316

DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-29-5-38.

Synopsis: Administrative fees for certain license plates. Requires the bureau of motor vehicles to distribute the annual supplemental fee collected for military veteran and military reserve vehicle license plates to the county fiscal body of the county in which the vehicles are registered. Requires the county fiscal body to distribute the money received to the county service officer for use in providing services to veterans.

Effective: July 1, 1998.

HOUSE BILL No. 1316

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 9-29-5-38 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 1998]: Sec. 38. (a) Except as
3 provided in subsection (c), vehicles registered under IC 9-18-25 are
4 subject to the following:
5 (1) An appropriate annual registration fee.
6 (2) An annual supplemental fee of ten dollars (\$10).
7 (3) Any other fee or tax required of a person registering a vehicle
8 under this title.
9 (b) **Except as provided in subsection (d)**, the bureau shall
10 distribute all money collected under the annual supplemental fee under
11 subsection (a)(2) as follows:
12 (1) Five dollars (\$5) from each registration is appropriated to the
13 bureau of motor vehicles for the purpose of administering
14 IC 9-18-25.
15 (2) Five dollars (\$5) from each registration shall be deposited in
16 the state license branch fund under IC 9-29-14.
17 (c) A vehicle registered under IC 9-18-25 that is owned by a former

1 prisoner of war or by the prisoner's surviving spouse is exempt from the
2 annual registration fee and the annual supplemental fee.
3 **(d) This subsection applies to an annual supplemental fee**
4 **collected for a military veteran or military reserve license plate.**
5 **The bureau shall distribute on an annual basis all annual**
6 **supplemental fees collected within a county for license plates**
7 **described in this subsection to the county fiscal body. The county**
8 **fiscal body shall distribute all money received under this subsection**
9 **to the county service officer appointed under IC 10-5-1-11 for the**
10 **county service officer's use in providing service to veterans.**
