MR. PRESIDENT:

I move that Senate Bill 470 be amended to read as follows:

- 1 Page 2, delete lines 14 through 42, begin a new line double block
2 indented and insert:
3 **"(A) Expense for textbooks and instructional materials.**

31 Page 4, delete lines 36 through 41.
32 Page 5, line 5, delete "least" and insert "**lesser**".
33 Page 5, line 6, after ";" insert "**or**".
34 Page 5, delete lines 7 through 13, begin a new line block indented
35 and insert:
36 **"(2) one hundred dollars (\$100) per dependent."**
37 Page 6, delete lines 7 through 31, begin a new line block indented

2 **"(1) Expense for textbooks and instructional materials.**
3 **However, the term does not include an expense for textbooks**
4 **and instructional materials for the teaching of religious**
5 **tenets, doctrines, or worship when the purpose of the**
6 **teaching is to instill religious tenets, doctrines, or worship."**
7 Page 6, line 39, delete "least" and insert "**lesser**".
8 Page 6, line 40, after ";" insert "**or**".
9 Page 6, line 41, delete "one thousand dollars (\$1,000)" and insert
10 **"one hundred dollars (\$100)".**
11 Page 6, line 41, delete "child; or" and insert "**dependent.**".
12 Page 6, delete line 42.
13 Page 7, line 6, delete "least" and insert "**lesser**".
14 Page 7, line 7, after ";" insert "**or**".
15 Page 7, line 8, delete "five" and insert "**one**".
16 Page 7, line 8, delete "\$500" and insert "**(\$100)**".
17 Page 7, line 8, delete "child; or" and insert "**dependent.**".
18 Page 7, delete line 9.
