MR. PRESIDENT:

I move that Senate Bill 115 be amended to read as follows:

- 6 Page 2, line 35, delete "affidavits" and insert "**an affidavit**".
- 7 Page 2, line 37, delete "counterpart." and insert "**copy.**".

- 27 Page 8, line 27, delete "counterparts, the total of which".
- 28 Page 8, line 28, delete "All counterparts" and insert "**A copy**".
- 29 Page 8, line 30, delete "counterpart" and insert "**any copy**".
- 30 Page 8, line 30, delete "counterparts" and insert "**copies**".
- 31 Page 8, line 34, strike "Strike all names appearing more than one
- 32 (1) time on the".
- 33 Page 8, strike line 35 and insert "**If a name appears more than**
- 34 **one (1) time on a petition or on a remonstrance, the clerk must**
- 35 **strike any duplicates of the name until the name appears only one**
- 36 **(1) time on a petition or a remonstrance, or both (if the person**
- 37 **signed both a petition and a remonstrance)."**.

- 41 Page 9, line 2, delete "on a single document or are not" and insert
- 42 ";".
- 43 Page 9, delete "duplicated on both the petition and remonstrance;".
- 44 Page 9, between lines 6 and 7, begin a new line blocked left and
- 45 insert:
- 46 **"The clerk of the circuit court may only strike a person's name**
- 47 **from a petition or a remonstrance as set forth in clauses (A) and**
