DIGEST OF SB 74 (Updated January 20, 1998 4:27 pm - DI 38)

Citations Affected: IC 14-8; IC 14-11.

Synopsis: Permits the department of natural resources to accept payment by credit card for licenses, fees or other purposes. Permits the department to enter into agreements with banks and other organizations and to pay service charges or fees.

SENATE BILL No. 74

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 14-8-2-62.1 IS ADDED TO THE INDIANA CODE
2 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 62.1. "Credit card", for purposes of**
4 **IC 14-11-1-7, has the meaning set forth in IC 14-11-1-7.**
- 5 SECTION 2. IC 14-11-1-7 IS ADDED TO THE INDIANA CODE
6 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
7 UPON PASSAGE]: **Sec. 7. (a) As used in this section, "credit card"**
8 **includes a bank card, debit card, charge card, prepaid card, or**
9 **other similar method of payment.**
- 10 **(b) In addition to other methods of payment allowed by law, the**
11 **department may accept payment by credit card for licenses, fees,**
12 **or other amounts due the department.**
- 13 **(c) The department may enter into appropriate agreements with**
14 **banks or other organizations authorized to do business in Indiana**
15 **to enable the department to accept payment by credit card.**
- 16 **(d) The department may recognize net amounts remitted by the**
17 **bank or other organization as deposit in full of amounts due the**

2 **(e) The department may pay any applicable credit card service**
3 **charge or fee.**
4 **SECTION 3. An emergency is declared for this act.**
