

COMMITTEE REPORT

MR. PRESIDENT:

The Senate Committee on Public Policy, to which was referred Senate Bill No. 67, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Delete the title and insert the following:
2 A BILL FOR AN ACT to amend the Indiana Code concerning the
3 general assembly and to make an appropriation.
4 Page 1, delete lines 1 through 17, begin a new paragraph and
5 insert:
6 "SECTION 1. IC 2-5-1.1-12 IS ADDED TO THE INDIANA
7 CODE AS A NEW SECTION TO READ AS FOLLOWS
8 [EFFECTIVE UPON PASSAGE]: **Sec. 12. (a) This section applies**
9 **only to a public agency in the legislative department of state**
10 **government.**
11 (b) The definitions in IC 5-14-3-2 apply throughout this
12 section.
13 (c) As used in this section, "legislative services" includes the
14 following:
15 (1) Providing a copy of a public record in the possession of a
16 public agency in the legislative department of state
17 government.
18 (2) Providing enhanced access to a public record in the

1 **possession of a public agency in the legislative department of**
2 **state government.**

3 **(3) Any other service:**

4 **(A) as defined by the legislative council; and**

5 **(B) provided by a public agency in the legislative**
6 **department of state government.**

7 **(d) A public agency shall charge the fee for providing a**
8 **legislative service under policies established by the legislative**
9 **council.**

10 **(e) The legislative council may establish by resolution**
11 **revolving accounts:**

12 **(1) for deposit of money received for providing legislative**
13 **services; and**

14 **(2) from which money may be used to support the provision**
15 **of legislative services;**

16 **as provided in the legislative council resolution. The auditor of**
17 **state shall keep appropriate entries in the auditor of state's records**
18 **to provide for proper accounting of the money in a revolving**
19 **account established under this subsection. The balance of a**
20 **revolving account established under this subsection does not revert**
21 **to the fund in which the account is established at the end of a state**
22 **fiscal year unless reversion is provided in the legislative council**
23 **resolution.**

24 **(f) Money in a revolving account established under subsection**
25 **(e) is appropriated for the purposes for which the revolving**
26 **account is established."**

28 Page 4, delete lines 1 through 15.

29 Page 4, line 18, delete "This section does not apply to a public".

30 Page 4, delete line 19.

31 Page 4, line 20, delete "(b)".

32 Page 4, run in lines 18 through 21.

34 Page 4, line 27, delete "(c) (d)" and insert: "(c)".

38 and insert:

- 3 **(2) public agency in the legislative department of state**
- 4 **government."**
- 5 Page 4, line 36, beginning with "The" begin a new line blocked
- 6 left.
- 7 Page 5, line 1, delete "(e) (f)" and insert: "(e)".

- 21 Page 6, delete lines 18 through 42, begin a new paragraph and
- 22 insert:
- 23 **"(I) Notwithstanding any other provision of this section, a**
- 24 **public agency within the legislative department of state**
- 25 **government shall charge any fee established under IC 2-5-1.1-12.**

- 1 **SECTION 3. An emergency is declared for this act."**
- 2 Delete pages 7 through 8.
- 3 Renumber all SECTIONS consecutively.
(Reference is to SB 67 as introduced.)
