

COMMITTEE REPORT

MR. PRESIDENT:

The Senate Committee on Agriculture and Small Business, to which was referred House Bill No. 1159, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 15-1.5-2-4 IS AMENDED TO READ AS
4 FOLLOWS [EFFECTIVE JULY 1, 1998]: Sec. 4. (a) The governor
5 shall appoint an individual qualified under sections 2 and 3 of this
6 chapter to fill a vacancy on the commission.
7 (b) The individual appointed by the governor under subsection (a)
8 serves the remainder of the unexpired term of the member the
9 individual replaces.
10 (c) **The period of the unexpired term for which an individual**
11 **serves after appointment under this section may not be considered**
12 **in determining the number of years that a member has served in a**
13 **twelve (12) year period for purposes of section 3(d) of this chapter.**
14 SECTION 2. IC 15-1.5-4-4 IS AMENDED TO READ AS
15 FOLLOWS [EFFECTIVE JULY 1, 1998]: Sec. 4. (a) The governor
16 shall appoint an individual qualified under sections 2 and 3 of this
17 chapter to fill a vacancy on the board.
18 (b) The individual appointed by the governor under subsection (a)
19 serves the remainder of the unexpired term of the member the
20 individual replaces.

- 1 (c) **The period of the unexpired term for which an individual**
- 2 **serves after appointment under this section may not be considered**
- 3 **in determining the number of years that a member has served in a**
- 4 **twelve (12) year period for purposes of section 3(d) of this**
- 5 **chapter."**
- 6 Page 1, line 1, delete "15-1.5-10" and insert "15-1.5-10.5".
- 7 Page 1, line 4, delete "10." and insert "**10.5**".
- 8 Page 1, line 14, delete "inform the public of" and insert "**educate**
- 9 **the public concerning**".
- 10 Page 2, line 5, delete "higher".
- 11 Page 4, line 29, delete "15-1.5-10-5" and insert "**15-1.5-10.5-5**".
- 12 Page 4, line 31, delete "15-1.5-10-4(a)(11)," and insert
- 13 "**15-1.5-10.5-4(a)(11)**".
- 14 Page 4, line 35, delete "15-1.5-10-5," and insert "**15-1.5-10.5-5**".
- 15 Page 5, line 1, delete "15-1.5-10-7," and insert "**15-1.5-10.5-7**".
- 16 Renumber all SECTIONS consecutively.
- (Reference is to HB 1159 as printed January 28, 1998.)
