

# COMMITTEE REPORT

---

## MR. PRESIDENT:

The Senate Committee on Finance, to which was referred Senate Bill No. 215, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1           Page 1, delete lines 1 through 15, begin a new paragraph and  
2           insert:  
3           "SECTION 1. THE FOLLOWING ARE REPEALED  
4           [EFFECTIVE UPON PASSAGE]: IC 12-8-13; P.L.13-1996, SECTION  
5           3."  
6           Delete page 2.  
7           Page 3, delete lines 1 through 15.  
8           Page 4, delete lines 35 through 42, begin a new paragraph and  
9           insert:  
10          "SECTION 3. [EFFECTIVE UPON PASSAGE] (a) **As used in**  
11          **this SECTION, "committee" refers to the central state advisory**  
12          **committee established by P.L.40-1994, SECTION 87, as amended**  
13          **by this act.**  
14          (b) **The committee shall obtain the following information**  
15          **regarding adults with mental illness:**  
16                (1) **The number of adults with mental illness.**  
17                (2) **The number of adults with mental illness confined by the**  
18                **department of correction.**

- 1           **(3) The number of adults with mental illness who will:**  
2                 **(A) be released by the department of correction; and**  
3                 **(B) require services for mental illness.**  
4           **(4) The number of adults with mental illness confined in**  
5           **county jails.**  
6           **(5) The number of adults with mental illness who will require**  
7           **services for mental illness.**  
8           **(6) The number of adults with mental illness who require**  
9           **services for mental illness who will not receive adequate**  
10           **services. The committee shall determine the reasons for any**  
11           **lack of needed services.**  
12           **(7) Classification of mental illness and associated numbers of**  
13           **adults with mental illness within each classification.**  
14           **(8) The requirements for services, including the types of**  
15           **placements needed, for all adults with mental illness.**  
16           **(9) The number of beds required to serve adults with mental**  
17           **illness.**  
18           **(c) The information gathered under subsection (b) must:**  
19                 **(1) include total information both for the entire state and for**  
20                 **the Central State catchment area; and**  
21                 **(2) be presented in a format of projections for each year,**  
22                 **beginning with 1998 through 2002.**  
23           **(d) The committee shall study the nature and scope of services**  
24           **required for each classification of mental illness determined under**  
25           **subsection (b)(7).**  
26           **(e) The committee shall study appropriate strategies for**  
27           **providing services to the numbers of adults within each**  
28           **classification of mental illness determined under subsection (b)(7),**  
29           **including the following:**  
30                 **(1) The kinds of private services available.**  
31                 **(2) An evaluation of the cost of purchasing private services**  
32                 **as compared to providing services in state institutional care.**  
33                 **(3) The nature and availability of alternate services.**  
34           **(f) The committee shall study funding and other fiscal issues**  
35           **related to providing appropriate services to adults with mental**  
36           **illness.**  
37           **(g) The committee shall study administrative issues related to**  
38           **providing appropriate services to adults with mental illness.**

1           **(h) The committee shall study whether there is a need for**  
2 **institutional care for adult individuals with mental illness at the**  
3 **site of Central State Hospital.**

4           **(i) The committee may study other issues the committee**  
5 **considers relevant to determine the best way to provide**  
6 **appropriate services to adults with mental illness.**

7           **(j) The division of mental health and other state agencies as**  
8 **determined by the committee shall:**

9               **(1) provide all information the committee considers**  
10 **appropriate to its study under this SECTION; and**

11               **(2) cooperate with the committee in the study required by**  
12 **this SECTION.**

13           **(k) The committee shall report the results of its study and its**  
14 **recommendations to the legislative council as the committee**  
15 **considers appropriate or as otherwise required by the legislative**  
16 **council.**

17           **(l) This SECTION expires July 1, 2001."**

18           Page 5, delete lines 1 through 39.

19           Renumber all SECTIONS consecutively.

(Reference is to SB 215 as printed January 16, 1998.)
