DIGEST OF HB1212 (Updated March 15, 1999 12:22 pm - DI 98)

Citations Affected: IC 14-31.

Synopsis: Ginseng season. Provides that the natural resources commission must adopt rules to establish the various seasons and times of the year for activities related to ginseng. (Under current law, the season is from August 15 through December 31 of each year.)

Effective: Upon passage.

ENGROSSED HOUSE BILL No. 1212

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 14-31-3-4 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 4. As used in this
3 chapter, "harvest season" means ~~August 15 through December 31~~ of
4 **each year: the season established by the commission under section**
5 **14(b)(1) of this chapter.**
- 6 SECTION 2. IC 14-31-3-9 IS AMENDED TO READ AS
7 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 9. (a) As used in
8 this section, "selling season" means ~~September 1 of one (1) year~~
9 **through March 31 of the following year: the season established by the**
10 **commission under section 14(b)(2) of this chapter.**
- 11 (b) Each ginseng dealer shall submit a summary of all ginseng
12 purchased and sold by the ginseng dealer during the selling season to
13 the department within thirty (30) days of the last day of the selling
14 season. The summary must also contain other information and be
15 prepared in the manner required by the department by rule.
- 16 SECTION 3. IC 14-31-3-10 IS AMENDED TO READ AS

3 (b) Ginseng harvested in Indiana may not be possessed by a ginseng

7 (c) Ginseng harvested in Indiana may not be bought, sold, or

12 (d) Ginseng that is harvested in Indiana may not be taken from
13 Indiana without written authorization from the department.

14 SECTION 4. IC 14-31-3-14 IS AMENDED TO READ AS
15 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 14. (a) The
16 department may adopt rules under IC 4-22-2 that are necessary to carry
17 out this chapter.

18 (b) **The commission shall adopt rules under IC 4-22-2 to do the**
19 **following:**

20 (1) **Establish the harvest season.**

21 (2) **Establish the selling season.**

22 (3) **Establish the part of a year when ginseng harvested in**
23 **Indiana may not be possessed by a ginseng harvester without**
24 **written authorization from the department.**

25 (4) **Establish the part of a year when ginseng harvested in**
26 **Indiana may not be bought, sold, or possessed by a ginseng**
27 **dealer without written authorization from the department.**

28 SECTION 5. An emergency is declared for this act.
