**Synopsis:** School bus committee members. Provides that the member of the state school bus committee selected by the School Transportation Association of Indiana is a voting member of the committee. (Under current law, the member is a nonvoting advisory member.)

## ENGROSSED HOUSE BILL No. 1248

---

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 20-9.1-4-1 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 1. (a) The state school  
3 bus committee is hereby created. The committee shall be composed of  
4 the following voting members:
- 5 (1) The state superintendent of public instruction, or the  
6 superintendent's authorized representative, who shall serve as  
7 chairman of the committee.
  - 8 (2) The commissioner of the state department of health, or the  
9 secretary's authorized representative.
  - 10 (3) The administrator of the special tax division of the department  
11 of state revenue.
  - 12 (4) The director of the Indiana office of traffic safety.
  - 13 (5) A member of the executive committee of the Indiana State  
14 Association of School Bus Drivers, Inc. who has been selected by  
15 the executive committee of that association.
  - 16 (6) A member of the Indiana Association of Public School

1 Superintendents who has been selected by the executive  
 2 committee of that association.  
 3 (7) A member of the Indiana School Boards Association who has  
 4 been selected by the board of directors of that association.  
 5 **(8) A member of the School Transportation Association of**  
 6 **Indiana selected by the board of directors of that association.**  
 7 (b) The committee shall elect a secretary who shall keep the official  
 8 record of the meetings and of official transactions of the committee.  
 9 The secretary shall serve for a term of one (1) year or until the  
 10 secretary's successor has been duly elected and qualified.  
 11 SECTION 2. IC 20-9.1-4-2 IS AMENDED TO READ AS  
 12 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 2. (a) The following  
 13 non-voting members shall advise the voting members of the state  
 14 school bus committee:  
 15 (1) A member of the Indiana Association of School Bus  
 16 Distributors selected by the executive committee of that  
 17 association.  
 18 (2) A member of the Indiana State Police selected by the state  
 19 police superintendent.  
 20 (3) A member of the Indiana Transportation Association selected  
 21 by the executive committee of that association.  
 22 (4) A member of the Indiana Township Association selected by  
 23 the executive committee of that association.  
 24 ~~(5) A member of the School Transportation Association of~~  
 25 ~~Indiana selected by the board of directors of that association.~~  
 26 (b) No person shall be qualified to serve as a non-voting member of  
 27 the committee until proper credentials of his appointment have been  
 28 filed with the chairman of the committee. Each non-voting member  
 29 shall be notified of all committee meetings and may attend each  
 30 meeting and offer advice to the voting members of the committee.
