DIGEST OF HB 1421 (Updated March 24, 1999 2:42 pm - DI 100)

Citations Affected: IC 4-4.

Synopsis: Aquaculture. Amends the definition of livestock. Provides that a person engaged in the business of aquaculture is eligible for the same consideration for grant and loan programs as a person engaged in other forms of farming.

Effective: July 1, 1999.

COMMITTEE REPORT

Mr. President: The Senate Committee on Agriculture and Small Business, to which was referred House Bill No. 1421 as printed February 3, 1999, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 4-4-3.2-1 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 1. (a) As used in this chapter, "commissioner" means the commissioner of agriculture.
