Summary of Legislation: This bill appropriates \$100,000 from the Build Indiana Fund to the city of Elwood, Madison County, for the State Road 13 sewer relocation project.

Effective Date: July 1, 1999.

Explanation of State Expenditures: This noncode bill appropriates \$100,000 from the Build Indiana Fund (BIF) to Elwood, Madison County beginning July 1, 1999, and ending June 30, 2001.

There are two accounts within the BIF: the Lottery and Gaming Surplus Account (LGSA) and the State and Local Capital Projects Account (SLCPA). Surplus lottery revenue, as well as revenue from the riverboat wagering tax, the parimutuel wagering tax, and charity gaming is deposited in the LGSA. A statutorily-determined amount of revenue in the LGSA is transferred each year to the Motor Vehicle Excise Tax Replacement Account (MVETRA) within the state General Fund. A portion of money remaining in the LGSA is then transferred to the SLCPA. Under this bill, \$100,000 would be transferred to Elwood, Madison County after money is transferred to MVETRA.

Based on projected lottery and gaming revenue to be deposited in the LGSA, there should be enough money in the BIF in FY 2000 and FY 2001 to cover the transfers to MVETRA and Elwood, Madison County, with

money remaining for other state and local projects. Therefore, no state General Fund appropriation will be necessary.

Explanation of Local Revenues: This noncode bill appropriates \$100,000 from the Build Indiana Fund (BIF) to Elwood, Madison County beginning July 1, 1999, and ending June 30, 2001. The appropriation is to be used for the State Road 13 sewer relocation project.
