MR. SPEAKER:

I move that House Bill 1639 be amended to read as follows:

- 1 Replace the effective dates in SECTIONS 1 through 4 with
- 2 "[EFFECTIVE JULY 1, 2001]".
- 3 Page 4, between lines 27 and 28, begin a new paragraph and
- 4 insert:
- 5 "SECTION 3. IC 9-15-2-2 IS AMENDED TO READ AS
- 6 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 2. (a) The commission
- 7 may do the following:
- 8 (1) Procure insurance against any loss in connection with the
- 9 commission's operations in the amount the commission considers
- 10 necessary or desirable.
- 11 (2) Contract for the operation of full service license branches
- 12 under IC 9-16-1-4 and partial services under IC 9-16-1-4.5.
- 13 (3) Take any other action necessary to achieve the commission's
- 14 purpose.
- 15 **(b) Before July 1, 2001, the commission may not do the**
- 16 **following:**
- 17 **(1) Close a license branch.**
- 18 **(2) Reduce the level of services provided at a license branch.**
- 19 **(3) Increase or impose a new service charge under**
- 20 **IC 9-29-3-19.**
- 21 **Although the commission may not close a license branch until after**
- 22 **June 30, 2001, the commission may eliminate positions of**
- 23 **employment.**
- 24 SECTION 4. IC 9-16-3-2 IS AMENDED TO READ AS

1 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 2. Based on the
 2 proposed budgets from each of the license branches, the commission
 3 shall develop a statewide license branch budget. If the commission
 4 determines that the total of:

5 (1) revenues from license branch operations; and

6 (2) appropriations received by the commission;

7 are insufficient to support license branch operations, the commission
 8 shall increase the branch service charges under IC 9-29-3. **However,**
 9 **the commission may not increase or impose a new branch service**
 10 **charge before July 1, 2001."**

11 Page 4, line 42, after "(c)" delete "A" and insert "**After June 30,**
 12 **2001, a"**.

13 Page 5, after line 15, begin a new paragraph and insert:

14 "SECTION 7. IC 9-29-3-22 IS AMENDED TO READ AS
 15 FOLLOWS [EFFECTIVE MAY 1, 1999 (RETROACTIVE)]: Sec. 22.
 16 (a) **Before May 1, 1999**, a new service charge or an increase in a
 17 service charge that is imposed by rule under section 19 of this chapter
 18 shall be:

19 (1) collected as an additional charge **to the license branch**
 20 **customer**; or

21 (2) withheld from any statutory fee.

22 (b) **After April 30, 1999, a new service charge or an increase**
 23 **in a service charge that is imposed by rule under section 19 of this**
 24 **chapter shall be collected as an additional charge to the license**
 25 **branch customer.**

26 SECTION 8. **An emergency is declared for this act."**

27 Renumber all SECTIONS consecutively.
