I move that House Bill 1868 be amended to read as follows:

- 1 Page 3, line 33, after "property" insert ";".
- 2 Page 42, line 38, after "any" delete "a" and insert "a".
- 3 Page 71, between lines 22 and 23, begin a new paragraph and
- 4 insert:
- 5 "SECTION 98. IC 36-7-31.3-1 IS AMENDED TO READ AS
- 6 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 1. This chapter applies
- 7 only to a city or a county without a consolidated city that has a
- 8 professional sports franchise playing the majority of its home games in
- 9 a facility owned by the city, the county, a school corporation, or a board
- 10 under **IC 36-9-13**, IC 36-10-8, IC 36-10-10, or IC 36-10-11."
- 11 Page 71, line 25, after "body" insert "**or the governing body of a**
- 12 **school corporation**".
- 13 Page 71, line 28, after "under" insert "**IC 36-9-13**".
- 14 Page 71, line 30, after "under" insert "**IC 36-9-13**".
- 15 Page 71, line 39, after "county," insert "**the school corporation**".
- 16 Page 71, line 40, after "under" insert "**IC 36-9-13**".
- 17 Page 72, line 5, delete "8(c)" and insert "**8(b)**".
- 18 Page 72, between lines 9 and 10, begin a new paragraph and
- 19 insert:
- 20 "SECTION 99. IC 36-7-31.3-19 IS AMENDED TO READ AS
- 21 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 19. The resolution
- 22 establishing the tax area must designate the use of the funds. The funds
- 23 are to be used only for:
- 24 (1) a capital improvement that will construct or equip a facility:

1 (A) owned by the city, the county, a school corporation, or  
2 a board under **IC 36-9-13**, IC 36-10-8, IC 36-10-10, or  
3 IC 36-10-11 and used by a professional sports franchise; or  
4 (B) owned by the city, the county, or a board under  
5 **IC 36-9-13**, IC 36-10-8, IC 36-10-10, or IC 36-10-11 and  
6 used for convention and tourism related events; or  
7 (2) the financing or refinancing of a capital improvement  
8 described in subdivision (1) or the payment of lease payments  
9 for a capital improvement described in subdivision (1)."  
10 Renumber all SECTIONS consecutively.
