MR. SPEAKER:

I move that House Bill 2022 be amended to read as follows:

- 1 Page 8, between lines 14 and 15, begin a new paragraph and
- 2 insert:
- 3 **"(b) A taxpayer may claim a credit allowed under this section**
- 4 **on a form prescribed by the state board of tax commissioners. The**
- 5 **form must include the amount and location of the taxpayer's**
- 6 **assessed valuation attributable to vehicles subject to taxation under**
- 7 **this chapter. The taxpayer shall submit the form with the**
- 8 **taxpayer's installment of property taxes due May 10, 2000. The**
- 9 **taxpayer shall apply the credit equally to each installment of**
- 10 **property taxes due under IC 6-1.1-22-9.**
- 11 **(c) The county auditor shall compute the total amount of**
- 12 **credits allowed in the county under this section. The county auditor**
- 13 **shall certify the following to the state board of tax commissioners**
- 14 **before July 1, 2000:**
- 15 **(1) The total amount of credits allowed in the county.**
- 16 **(2) The amount of credits attributable to each taxing unit of**
- 17 **the county."**
- 18 Page 8, line 15, delete "(b)" and insert "(d)".
- 19 Page 8, between lines 38 and 39, begin a new paragraph and
- 20 insert:
- 21 **"(c) A contractor providing:**
- 22 **(1) a full service license branch under IC 9-16-1-4; or**
- 23 **(2) a partial service license branch under IC 9-16-1-4.5,**
- 24 **shall remit the amount of commercial vehicle excise tax collected**

- 1 **each week to the bureau of motor vehicles for deposit into the**
 2 **commercial vehicle excise tax fund."**
 3 Page 9, line 24, delete "The determination shall".
 4 Page 9, delete line 25.
 5 Page 9, line 26, delete "of motor vehicles."
 6 Page 10, line 3, after "shall" insert "**determine the total amount**
 7 **of commercial vehicle excise taxes attributable to each taxing unit**
 8 **in the county and the amount determined shall be apportioned and**
 9 **distributed among the respective funds of each taxing unit in the**
 10 **same manner and at the same time as property taxes are**
 11 **apportioned and distributed."**
 12 Page 10, delete lines 4 through 7.
 13 Page 10, line 11, delete "state board of tax commissioners" and
 14 insert "**auditor of state**".
 15 Page 10, line 12, delete "August" and insert "**July**".
 16 Page 10, line 12, after "furnish" insert "**to each county auditor an**
 17 **estimate of the amounts to be distributed to the counties under this**
 18 **section during the next calendar year. Before August 1, each**
 19 **county auditor shall furnish**".
 20 Page 10, line 13, after "unit" insert "**of the county**".
 21 Page 10, line 26, delete "17" and insert "**18**".
 22 Page 18, delete lines 15 through 42.
 23 Page 19, delete lines 1 through 38.
 24 Page 25, line 22, delete "(a)".
 25 Page 25, delete lines 25 through 41.
 26 Renumber all SECTIONS consecutively.
