**MR. SPEAKER:**

I move that House Bill 1955 be amended to read as follows:

- 1           Page 1, line 11, delete "the change is approved by the" and insert
- 2           **"a member of the governing body of:**
- 3                 **(1) the school corporation; and**
- 4                 **(2) the county;**
- 5           **participates in the zoning decision in the manner required by**
- 6           **IC 36-7-4-602."**
- 7           Page 1, delete lines 12 through 17.
- 8           Page 2, delete line 1.
- 9           Page 2, delete lines 11 through 13.
- 10          Page 2, line 14, reset in roman "(3)".
- 11          Page 2, line 14, delete "(4)".
- 12          Page 2, line 16, reset in roman "(4)".
- 13          Page 2, line 16, delete "(5)".
- 14          Page 2, between lines 17 and 18, begin a new line block indented
- 15          and insert:
- 16                 **"(5) This subdivision applies when a proposal involves**
- 17                 **property within a school corporation district described in**
- 18                 **IC 20-5-2-9. The plan commission must give notice of the**
- 19                 **proposal to the governing body of:**
- 20                         **(i) the school corporation; and**
- 21                         **(ii) the county;**
- 22                 **at least thirty (30) days before the plan commission holds a**
- 23                 **public hearing under section 604 of this chapter.**

- 25                 **(6) This subdivision applies when a proposal involves**
- 26                 **property within a school corporation district described in IC**

2                 **(i) the school corporation; and**

5           **member of the plan commission during the time when the**  
6           **plan commission holds the public hearing on the proposal."**  
7           Page 2, line 18, delete "(6)" and insert "(7)".  
8           Page 2, line 20, delete "(7)" and insert "(8)".  
9           Page 2, line 22, after "." insert "**However, when a proposal**  
10           **involves property within a school corporation district**  
11           **described in IC 20-5-2-9, the governing body of:**  
12                 **(i) the school corporation; and**  
13                 **(ii) the county;**  
14           **may appoint one (1) of its members to serve as a non-voting**  
15           **member of the legislative body during the time when the**  
16           **legislative body considers the proposal."**  
17           Page 2, line 23, delete "(8)" and insert "(9)".  
18           Page 2, line 26, delete "(9)" and insert "(10)".  
19           Page 5, delete lines 16 through 19, begin a new paragraph and  
20           insert:  
21                 **"(l) This subsection applies when a proposal involves property**  
22                 **within a school corporation district described in IC 20-5-2-9. The**  
23                 **governing body of:**  
24                         **(1) the school corporation; and**  
25                         **(2) the county;**  
26                 **must receive notice of the proposal at least forty-five (45) days**  
27                 **before the board of zoning appeals considers the proposal.**  
28                 **(m) This subsection applies when a proposal involves property**  
29                 **within a school corporation district described in IC 20-5-2-9. The**  
30                 **governing body of:**  
31                         **(1) the school corporation; and**  
32                         **(2) the county;**  
33                 **may appoint one (1) of its members to serve as a non-voting**  
34                 **member of the board of zoning appeals during the time when the**  
35                 **board of zoning appeals considers the proposal."**
