MR. SPEAKER:

I move that Engrossed Senate Bill 31 be amended to read as follows:

- 1 Page 3, between lines 17 and 18, begin a new subparagraph and
- 2 insert: "**(CC) IC 9-18-46 (Indiana Street Rodders' Association trust**
- 3 **license plate);**"
- 4 Page 3, line 19, delete "(CC)" and insert "**(DD)**".
- 5 Page 11, between lines 6 and 7, begin a new paragraph and insert:
- 6 "SECTION 16. IC 9-18-46 IS ADDED TO THE INDIANA CODE
- 7 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 8 JANUARY 1, 2001]:
- 9 **Chapter 46. Indiana Street Rodders' Association Trust License**
- 10 **Plates Sec. 1. The bureau of motor vehicles shall design and**
- 11 **issue an Indiana Street Rodders' Association trust license plate.**
- 12 **The Indiana Street Rodders' Association trust license plate shall be**
- 13 **designed and issued as a special group recognition license plate**
- 14 **under IC 9-18-25.**
- 15 **Sec. 2. After December 31, 2000, a person who is eligible to**
- 16 **register a vehicle under this title is eligible to receive an Indiana**
- 17 **Street Rodders' Association trust license plate under this chapter**
- 18 **upon doing the following:**
- 19 **(1) Completing an application for an Indiana Street**
- 20 **Rodders' Association trust license plate.**
- 21 **(2) Paying the fees under section 3 of this chapter.**
- 22 **Sec. 3. (a) The fees for an Indiana Street Rodders' Association**
- 23 **trust license plate are as follows:**
- 24 **(1) The appropriate fee under IC 9-29-5-38(a).**
- 25 **(2) An annual fee of twenty-five dollars (\$25).**

- 1 **(b) The annual fee referred to in subsection (a)(2) shall be**
2 **collected by the bureau.**
- 3 **(c) The annual fee described in subsection (a)(2) shall be**
4 **deposited in the fund established by section 4 of this chapter.**
- 5 **Sec. 4. (a) The Indiana Street Rodders' Association trust fund**
6 **is established.**
- 7 **(b) The treasurer of state shall invest the money in the fund**
8 **not currently needed to meet the obligations of the fund in the same**
9 **manner as other public trust funds are invested. Interest that**
10 **accrues from these investments shall be deposited in the fund.**
- 11 **(c) The commissioner shall administer the fund. Expenses of**
12 **administering the fund shall be paid from money in the fund.**
- 13 **(d) On June 30 of each year the commissioner shall distribute**
14 **the money from the fund to the Indiana Street Rodders'**
15 **Association.**
- 16 **(e) Money in the fund at the end of a state fiscal year does not**
revert to the state general fund. "
