- 19 Page 20, between lines 34 and 35, begin a new paragraph and

- 22 CODE AS A NEW CHAPTER TO READ AS FOLLOWS:
- 23 [EFFECTIVE JULY 1, 1999]: **Chapter 22.3 Preliminary Scholastic**
- 24 **Assessment Test (PSAT) Program.**
- 25 **Sec. 1. As used in this chapter, "commission" refers to the**
- 26 **commission for higher education established by IC 20-12-0.5-2.**
- 27 **Sec. 2. As used in this chapter, "eligible student" means a**

1 student who is:
2 (1) in grade 10 or 11, if the student is enrolled in a public or
3 nonpublic school or the equivalent academic level under a
4 program of homebased instruction; and
5 (2) a resident of Indiana.
6 Sec. 3. As used in this chapter, "program" refers to the
7 preliminary scholastic assessment test/national merit scholarship
8 qualifying test.
9 Sec. 4. As used in this chapter, "PSAT" refers to the
10 preliminary scholastic assessment test/national merit scholarship
11 qualifying test.
12 Sec. 5. The PSAT program is established to encourage eligible
13 students to take the PSAT. The department and the commission
14 shall administer the program jointly.
15 Sec. 6. (a) The program shall provide each eligible student
16 who:
17 (1) qualifies to take the PSAT;
18 (2) wishes to take the PSAT; and
19 (3) is appropriately registered to take the PSAT;
20 the opportunity to take the PSAT at no cost to the student.
21 (b) An eligible student may take the PSAT at no cost two times
22 under the program.
23 Sec. 7. The department and the commission shall prepare an
24 annual report concerning the implementation of the program and
25 shall submit the report to the board before December 1 of each
26 year. The report must include the pertinent details of the program,
27 including the following:
28 (1) The number of students participating in the program.
29 (2) Recent trends in the field of preliminary scholastic
30 assessment testing.
31 (3) The distribution of money under this program.
32 (4) Other pertinent matters.
33 Sec. 9. The board and the commission may adopt rules under
34 IC 4-22-2 to implement this chapter."
