Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1998 General Assembly.

## HOUSE BILL No. 1059

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 9-13-2-121.1 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 1999]: **Sec. 121.1. "Part-time", for purposes**  
4 **of IC 9-16-1, has the meaning set forth in IC 9-16-1-1.1.**  
5 SECTION 2. IC 9-16-1-1.1 IS ADDED TO THE INDIANA CODE  
6 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
7 1, 1999]: **Sec. 1.1. As used in this chapter, "part-time" means at**  
8 **least two (2) days each week.**  
9 SECTION 3. IC 9-16-1-3.1 IS ADDED TO THE INDIANA CODE  
10 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
11 1, 1999]: **Sec. 3.1. At least one (1) license branch must be**  
12 **established and operated on at least a part-time basis in the county**  
13 **seat of each county.**
