# HOUSE BILL No. 1065

DIGEST OF HB1065 (Updated January 14, 1999 10:08 am - DI 69)

**Citations Affected:** IC 31-14-14-1.5; IC 31-17-4-1.5.

**Synopsis:** Visitation rights. Prohibits a court from granting visitation rights with a child to a parent who has been convicted of murder of the child's other parent unless the court finds that: (1) the statutory requirements entitling a parent to reasonable visitation under current law are met; (2) the child is of a reasonable age to agree to the visitation; and (3) the child consents to the visitation.

**Effective:** July 1, 1999.

## HOUSE BILL No. 1065

A BILL FOR AN ACT to amend the Indiana Code concerning family law and juvenile law.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 31-14-14-1.5 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 1999]: **Sec. 1.5. A court may not grant**  
4 **visitation rights with a child to a parent who has been convicted of**  
5 **murder under IC 35-42-1-1 of the child's other parent unless the**  
6 **court finds that all of the following conditions exist:**

- 7 (1) **The parent is entitled to reasonable visitation under**  
8 **section 1 of this chapter.**  
9 (2) **The child is of reasonable age to demonstrate that the child**  
10 **approves of the visitation order.**  
11 (3) **The child consents to the visitation.**

12 SECTION 2. IC 31-17-4-1.5 IS ADDED TO THE INDIANA CODE  
13 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
14 1, 1999]: **Sec. 1.5. A court may not grant visitation rights with a**  
15 **child to a parent who has been convicted of murder under**  
16 **IC 35-42-1-1 of the child's other parent unless the court finds that**  
17 **all of the following conditions exist:**
