DIGEST OF HB1211 (Updated January 20, 1999 6:28 pm - DI 02)

**Citations Affected:** IC 14-24.

**Synopsis:** Inspection of nurseries by department of natural resources. Provides that the division of entomology and plant pathology of the department of natural resources is required to make an annual inspection of plant nurseries that import stock into and export stock from Indiana. (The introduced version of this bill was prepared by the natural resources study committee.)

**Effective:** July 1, 1999.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1998 General Assembly.

## HOUSE BILL No. 1211

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 14-24-5-2 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 2. **(a)** The division shall  
3 inspect each nursery in Indiana at least one (1) time each year **if the**  
4 **nursery:**

5 **(1) imports nursery stock from outside Indiana; or**

6 **(2) exports nursery stock from Indiana.**

7 **(b)** The division director may authorize ~~additional~~ nursery  
8 inspections **in addition to those nursery inspections described in**  
9 **subsection (a).**
