Citations Affected: IC 20-1.

Synopsis: Education information by ethnicity and gender. Requires the department of education to compile statistics concerning the ethnicity and gender of students in Indiana schools on all information concerning students that the department of education receives from school corporations on enrollement, number of suspensions, and number of expulsions.

Effective: July 1, 1999.

HOUSE BILL No. 1300

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 20-1-1.1-5 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 5. The department
3 shall:
4 (1) perform the duties required by statute;
5 (2) implement the policies and procedures established by the
6 board;
7 (3) conduct analytical research to assist the state board of
8 education in determining the state's educational policy;
9 (4) **for all information concerning students that the**
10 **department receives from school corporations on enrollment,**
11 **number of suspensions, and number of expulsions,** compile
12 statistics concerning the ethnicity and gender of students in
13 Indiana schools; and
14 (5) provide technical assistance to school corporations.
