HOUSE BILL No. 1325



A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 36-5-7-6 IS AMENDED TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 1999]: Sec. 6. (a) **The town legislative body**
3 **shall by ordinance fix the number of deputy marshals.** The town
4 legislative body may by ordinance authorize the marshal to appoint
5 deputy marshals. Deputy marshals have the powers and liabilities of the
6 marshal in executing the orders of the legislative body or enforcing
7 laws.
8 (b) One (1) deputy marshal may be designated as the town humane
9 officer. He has the duties prescribed by IC 36-8 for city humane
10 officers.
11 (c) The legislative body shall fix the amount of bond, compensation,
12 and term of service of deputy marshals. The marshal may dismiss a
13 deputy marshal at any time. However, a deputy marshal who has been
14 employed by the town for more than six (6) months after completing
15 the minimum basic training requirements adopted by the law
16 enforcement training board under IC 5-2-1-9 may be dismissed only if
17 the procedure prescribed by section 3 of this chapter is followed.
