**Synopsis:** Study of livestock production contracts. Requires the attorney general and the commissioner of agriculture to jointly conduct a study of the contractual arrangements prevalent throughout the livestock production industry.

## HOUSE BILL No. 1638

A BILL FOR AN ACT concerning agriculture.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1           SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **The attorney**  
2 **general and the commissioner of agriculture shall jointly conduct**  
3 **a study of the contractual arrangements prevalent throughout the**  
4 **livestock production industry.**  
5           (b) **The study must conclude by December 1, 1999.**  
6           (c) **By December 31, 1999, the attorney general and the**  
7 **commissioner of agriculture shall jointly report to the legislative**  
8 **council the findings and recommendations of the study conducted**  
9 **under subsection (a).**  
10          (d) **This SECTION expires January 1, 2000.**  
11          SECTION 2. **An emergency is declared for this act.**
