DIGEST OF HB1744 (Updated February 16, 1999 12:35 pm - DI 94)

Citations Affected: IC 36-8.

Synopsis: Pre-planning fire inspections. Provides that a paid fire department or a volunteer fire company may make a pre-planning inspection for the purpose of advising the department or company on issues affecting fire suppression response. Provides that the fire department or volunteer fire company shall be allowed entry and access for the purpose of making a pre-planning inspection.

Effective: July 1, 1999.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in **this style type**.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or *this style type* reconciles conflicts between statutes enacted by the 1998 General Assembly.

HOUSE BILL No. 1744

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 36-8-17.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 1999]:

4 **Chapter 17.5. Pre-Planning Inspections**
5 **Sec. 1. As used in this chapter, "fire department" has the**
6 **meaning set forth in IC 36-8-17-2.**

7 **Sec. 2. A fire department may make a pre-planning inspection**
8 **of every place and public way within the jurisdiction of the political**
9 **subdivision that the fire department serves, except the interiors of**
10 **private dwellings, for the purpose of advising the fire department**
11 **on issues affecting a fire suppression response.**

12 **Sec. 3. A fire department shall be allowed entry and access to**
13 **every place or public way within the jurisdiction of the political**
14 **subdivision that the fire department serves, except the interiors of**
15 **private dwellings, for the purpose of making a pre-planning**
16 **inspection under this chapter.**
