



**CONFERENCE COMMITTEE REPORT
DIGEST FOR HB 1235**

Citations Affected: 8-6-4-1; noncode.

Synopsis: Regulation of train whistles. Conference committee report for EHB 1235. Regulation of train whistles. Allows a city, town, or county to adopt an ordinance regulating the use of train whistles. Prohibits a city, town, or county from regulating by ordinance the sounding of a whistle or the ringing of a bell at a railroad crossing that does not have an automatic railroad activated warning signal. Requires, rather than allows, the department of transportation to grant permission to a city, town, or county if the department determines that the ordinance will not cause undue risk of harm to the public. (This conference committee report does the following: (1) allows a county to adopt an ordinance regulating the use of a train whistle; and (2) requires the department of transportation to grant permission if the department determines the ordinance will not cause undue risk of harm to the public.)
