- 3 Page 8, line 39, delete "Self-Insurance" and insert "**Employee**
- 4 **Health**".
- 5 Page 8, line 41, delete "a self-insurance" and insert "**an employee**
- 6 **health**".
- 7 Page 9, between lines 3 and 4, begin a new paragraph and insert:
- 8 "**(c) For purposes of this chapter, "employee health plan"**
- 9 **means:**
- 10 **(1) a self-insurance plan;**
- 11 **(2) a group contract entered into or renewed by a state**
- 12 **educational institution with a health maintenance**
- 13 **organization (as defined in IC 27-13-1-19) to provide services**

- 1 **to employees of the state educational institution; or**
 2 **(3) a policy of accident and sickness insurance (as defined in**
 3 **IC 27-8-5-1) issued or renewed on a group basis to a state**
 4 **educational institution to provide coverage for employees of**
 5 **the state educational institution."**

- 31 **(3) Worker's compensation or similar insurance.**
- 32 **(4) Automobile medical payment insurance.**
- 33 **(5) A specified disease policy issued as an individual policy.**
- 34 **(6) A limited benefit health insurance plan issued as an**
 35 **individual policy.**
- 36 **(7) A short term insurance plan that:**
- 37 **(A) may not be renewed; and**
- 38 **(B) has a duration of not more than six (6) months.**

1 **(8) A policy that provides a stipulated daily, weekly, or**
2 **monthly payment to an insured during hospital confinement,**
3 **without regard to the actual expense of the confinement."**

4 Page 10, delete line 17.

5 Page 10, line 34, before "as" insert "**and covered under the health**
6 **insurance plan"**.
