*Your Committee on Local Government, to which was referred House Bill 1024, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 31-11-6-1 IS AMENDED TO READ AS
- 4 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 1. Marriages may be
- 5 solemnized by any of the following:
- 6 (1) A member of the clergy of a religious organization (even if the
- 7 cleric does not perform religious functions for an individual
- 8 congregation), such as a minister of the gospel, a priest, a bishop,
- 9 an archbishop, or a rabbi.
- 10 (2) A judge.
- 11 (3) A mayor, within the mayor's ~~city~~ **county**.
- 12 (4) A clerk or a clerk-treasurer of a city or town, within a county
- 13 in which the city or town is located.
- 14 (5) A clerk of the circuit court.
- 15 (6) The Friends Church, in accordance with the rules of the
- 16 Friends Church.

1 (7) The German Baptists, in accordance with the rules of their
2 society.

3 (8) The Bahai faith, in accordance with the rules of the Bahai
4 faith.

5 (9) The Church of Jesus Christ of Latter Day Saints, in
6 accordance with the rules of the Church of Jesus Christ of Latter
7 Day Saints.

8 (10) An imam of a masjid (mosque), in accordance with the rules
9 of the religion of Islam."

10 Page 1, line 2, delete the effective date "[EFFECTIVE JULY 1,
11 1999]" and insert the effective date "[EFFECTIVE UPON
12 PASSAGE]".

13 Page 1, line 13, delete the effective date "[EFFECTIVE JULY 1,
14 1999]" and insert the effective date "[EFFECTIVE UPON
15 PASSAGE]".

16 Page 1, line 15, strike "Whenever the legislative body has an even
17 number of members".

18 Page 1, line 16, delete "present at a meeting of the legislative
19 body,".

20 Page 1, line 16, strike "for any reason,".

21 Page 1, line 16, delete "the" and insert "The".

22 Page 2, between lines 1 and 2, begin a new paragraph and insert:
23 "SECTION 3. IC 36-5-2-13 IS ADDED TO THE INDIANA CODE
24 AS A **NEW SECTION TO READ AS FOLLOWS** [EFFECTIVE
25 UPON PASSAGE]: **Sec. 13. The town executive must have the**
26 **approval of a majority of the town board before the executive may**
27 **discharge or remove a town employee.**".

28 Page 2, line 3, delete the effective date "[EFFECTIVE JULY 1,
29 1999]" and insert the effective date "[EFFECTIVE UPON
30 PASSAGE]".

- 1 Page 2, after line 33, begin a new paragraph and insert:
- 2 "SECTION 5. **An emergency is declared for this act.**".
- 3 Renumber all sections consecutively.
(Reference is to HB 1024 as introduced.)
