*Your Committee on Insurance, Corporations and Small Business, to which was referred House Bill 2043, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Delete pages 1 through 3.
- 2 Page 4, delete lines 1 through 21.
- 3 Page 4, between lines 30 and 31, begin a new paragraph and insert:
- 4 "SECTION 2. IC 27-1-1-6 IS ADDED TO THE INDIANA CODE
- 5 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**
- 6 **1, 1999]: Sec. 6. (a) All employees of the department except:**
- 7 **(1) the commissioner;**
- 8 **(2) the chief deputy commissioner;**
- 9 **(3) other deputy commissioners; and**
- 10 **(4) clerical staff;**
- 11 **shall comply with the continuing education requirements**
- 12 **established for a licensed insurance agent under IC 27-1-15.5-7.1.**
- 13 **(b) This section does not require employees of the department**
- 14 **to obtain an insurance agent's license.**
- 15 **(c) The department shall, not later than July 1 of each year,**
- 16 **submit a report to the legislative council regarding compliance**

- 1 **with this section.**
- 2 **(d) All costs associated with this section shall be paid from the**
- 3 **department of insurance fund established under IC 27-1-3-28."**
- 4 Page 4, delete lines 31 through 42.
- 5 Delete page 5.
- 6 Page 6, delete lines 1 through 37.
- 7 Page 7, between lines 12 and 13, begin a new line block indented
- 8 and insert:
- 9 **"(6) To pay the costs associated with IC 27-1-1-6 concerning**
- 10 **continuing education of department employees."**
- 11 Page 7, line 16, reset in roman "IC 27-1-3-15(d)."
- 12 Page 7, line 16, delete "IC 27-1-3-15(c)."
- 13 Page 7, line 18, reset in roman "IC 27-1-3-15(c)."
- 14 Page 7, line 18, delete "IC 27-1-3-15(d)."
- 15 Page 7, between lines 32 and 33, begin a new paragraph and insert:
- 16 "SECTION 4. IC 27-13-36-2.5 IS ADDED TO THE INDIANA
- 17 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 18 [EFFECTIVE JULY 1, 1999]: **Sec. 2.5. A health maintenance**
- 19 **organization may not discriminate against a provider acting within**
- 20 **the scope of the provider's license or certification with respect to:**
- 21 **(1) participation;**
- 22 **(2) reimbursement;**
- 23 **(3) indemnification; or**
- 24 **(4) scope of care;**
- 25 **solely on the basis of the provider's license or certification."**
- 26 Page 7, delete lines 33 through 42.
- 27 Delete pages 8 through 83
- 28 Page 84, delete lines 1 through 30.
- 29 Renumber all SECTIONS consecutively.
