Mr. Speaker: Pursuant to Joint Rule 20, your Committee on Rules and Legislative Procedures, to which was referred Engrossed Senate Bill 606 because it conflicts with SEA 40-1999, SEA 307-1999, and HEA 2034-1999 without properly recognizing the existence of SEA 40-1999, SEA 307-1999, and HEA 2034-1999, has had Engrossed Senate Bill 606 under consideration and begs leave to report back to the House with the recommendation that Engrossed Senate Bill 606 be corrected as follows:
