Whereas, The North Central High School Men's Basketball Team earned the title, 1999 IHSAA 4A Men's Basketball Team Champion;

Whereas, In tournament competition between the four division champion high school men's basketball teams, one week after earning the Division 4A title the North Central High School Men's Basketball Team won the tournament and earned the title, "Tournament of Champions" Champion;
