Whereas, Rick was a dedicated and loving husband to his wife, Joanne, and loving father to his four children, Jared, Heather, Kayla and Nathan;

Whereas, Rick, at age 42, suddenly collapsed and passed away on December 13, 1998, while participating in one of his most enjoyable activities -- playing basketball with his son, Jared;

Whereas, Rick will forever be remembered as a man committed to his family, his profession, to his alma mater and to his Lord;

Whereas, Rick was a very successful investment broker, named the most successful broker in the country for Edward D. Jones, but left the business of high finance to devote his life to educating young people, spending the last ten years of his life investing in the lives of college students at Taylor University;
