

# HOUSE BILL No. 1101

---

## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 9-18.

**Synopsis:** Boys and girls clubs license plates. Requires the bureau of motor vehicles to design and issue a special group recognition license plate for the Indiana Boys and Girls Clubs. Provides that a person who is eligible to register a vehicle may obtain an Indiana Boys and Girls Clubs license plate upon completing an application and paying an appropriate fee. Exempts the Indiana Boys and Girls Clubs license plate from sales requirements for special group recognition license plates.

**Effective:** January 1, 2000.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 9-18-15-1 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JANUARY 1, 2000]: Sec. 1. (a) A person  
3 who is the registered owner or lessee of a:  
4 (1) passenger motor vehicle;  
5 (2) motorcycle;  
6 (3) recreational vehicle; or  
7 (4) vehicle registered as a truck with a declared gross weight of  
8 not more than:  
9 (A) eleven thousand (11,000) pounds;  
10 (B) nine thousand (9,000) pounds; or  
11 (C) seven thousand (7,000) pounds;  
12 registered with the bureau or who makes an application for an original  
13 registration or renewal registration of a vehicle may apply to the bureau  
14 for a personalized license plate to be affixed to the vehicle for which  
15 registration is sought instead of the regular license plate.  
16 (b) A person who:  
17 (1) is the registered owner or lessee of a vehicle described in

36 SECTION 2. IC 9-18-25-1.5 IS ADDED TO THE INDIANA CODE  
 37 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**  
 38 **JANUARY 1, 2000]: Sec. 1.5. Sections 15 and 16 of this chapter do**  
 39 **not apply to a license plate issued under IC 9-18-45.**

40 SECTION 3. IC 9-18-45 IS ADDED TO THE INDIANA CODE AS  
 41 A **NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE**  
 42 **JANUARY 1, 2000]:**

- 2           **Sec. 1. The bureau shall design and issue an Indiana Boys and**
- 3           **Girls Clubs license plate under IC 9-18-25.**
- 4           **Sec. 2. After December 31, 1999, a person who is eligible to**
- 5           **register a vehicle under this title is eligible to receive an Indiana**
- 6           **Boys and Girls Clubs license plate upon doing the following:**
- 7           **(1) Completing an application for an Indiana Boys and Girls**
- 8           **Clubs license plate.**
- 9           **(2) Paying the appropriate fee under IC 9-29-5-38(a).**
