DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-12-57.5.

Synopsis: Ball State contractor benefits. Requires Ball State University to provide the same health insurance benefits to individuals who teach or provide other services under a contract with the university as the university provides to its employees.

Effective: July 1, 1999.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-12-57.5-11 IS AMENDED TO READ AS
 2 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 11. ~~(Board: Body~~
 3 ~~Corporate; Powers)~~ The board of trustees shall constitute a perpetual
 4 body corporate with power to:
 5 (a) (1) manage, control and operate Ball State University;
 6 (b) (2) sue and be sued;
 7 (c) (3) let contracts;
 8 (d) (4) borrow money and issue bonds as authorized by the
 9 Indiana General Assembly;
 10 (e) (5) prescribe conditions for admission;
 11 (f) (6) grant degrees and issue diplomas or certificates;
 12 (g) (7) fix laboratory, contingent, and other fees and charges;
 13 (h) (8) set fines and penalties;
 14 (i) (9) **subject to section 12 of this chapter**, define the duties and
 15 provide compensation for faculty and staff of the university,
 16 including authority to establish fringe benefit programs including
 17 retirement benefits which may be supplemental to, or in lieu of,



- 1 state retirement programs for teachers or other public employees
 2 as authorized by law;
 3 ~~(j)~~ **(10)** receive and administer all donations, bequests, grants,
 4 funds, and property which are given to or provided for the
 5 university;
 6 ~~(k)~~ **(11)** promulgate rules and regulations pursuant to this chapter;
 7 ~~(l)~~ **(12)** exercise all powers, rights, privileges, and duties
 8 conferred upon the board by other laws of the general assembly;
 9 and
 10 ~~(m)~~ **(13)** to possess all other power in order to efficiently operate
 11 the affairs of Ball State University.

12 SECTION 2. IC 20-12-57.5-12 IS ADDED TO THE INDIANA
 13 CODE AS A NEW SECTION TO READ AS FOLLOWS
 14 [EFFECTIVE JULY 1, 1999]: **Sec. 12. (a) This section applies to an**
 15 **individual who:**

- 16 **(1) has entered into a contract with Ball State University to**
 17 **provide teaching or other services for the university; and**
 18 **(2) is not an employee of Ball State University.**
 19 **(b) The Ball State University board of trustees shall provide an**
 20 **individual described in subsection (a) with health insurance**
 21 **benefits:**
 22 **(1) that are identical to the benefits of an employee of the**
 23 **university who holds a position similar to that of the**
 24 **individual; and**
 25 **(2) at the same cost to the individual as that paid by an**
 26 **employee of the university.**
