## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 9-18-34.

**Synopsis:** Professional firefighter license plates. Provides that: (1) only a person who is a full-time, salaried firefighter is eligible to receive an Indiana firefighter license plate; and (2) the bureau of motor vehicles shall consult only with representatives of the Professional Firefighters of Indiana, Inc., in designing the Indiana firefighters license plate.

**Effective:** January 1, 2000.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 9-18-34-1 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JANUARY 1, 2000]: Sec. 1. As used in this  
3 chapter, "Indiana firefighter" means a person who is  
4 (†) a full-time, salaried firefighter. ~~or~~  
5 (‡) a volunteer firefighter (as defined in IC 36-8-12-2).  
6 SECTION 2. IC 9-18-34-2 IS AMENDED TO READ AS  
7 FOLLOWS [EFFECTIVE JANUARY 1, 2000]: Sec. 2. (a) The bureau  
8 shall issue an Indiana firefighter license plate. The Indiana firefighter  
9 license plate shall be designed and issued as a special group  
10 recognition license plate under IC 9-18-25.  
11 (b) The bureau shall confer with representatives of the Professional  
12 Firefighters Union of Indiana, and the Indiana Firefighters Association  
13 **Inc.**, concerning a design for the emblem that identifies the vehicle as  
14 being registered to a firefighter as prescribed under IC 9-18-25-5.
