A BILL FOR AN ACT concerning utilities and transportation.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. P.L.241-1997, SECTION 1, IS AMENDED TO READ  
2 AS FOLLOWS [EFFECTIVE JULY 1, 1999]: SECTION 1. (a) As used  
3 in this SECTION, "member" refers to a person appointed under  
4 subsection (c)(3) or (c)(4) or to a legislator whose district includes all  
5 or part of Lake County, Porter County, LaPorte County, St. Joseph  
6 County, or Elkhart County.  
7 (b) The northwest Indiana commuter rail and transportation study  
8 commission is established.  
9 (c) The commission consists of fourteen (14) voting members  
10 appointed as follows:  
11 (1) Six (6) members of the senate, not more than three (3) of  
12 whom may be members of the same political party, appointed by  
13 the president pro tempore of the senate.  
14 (2) Six (6) members of the house of representatives, not more  
15 than three (3) of whom may be members of the same political  
16 party, appointed by the speaker of the house of representatives.  
17 (3) One (1) individual who is not a legislator, appointed by the  
18 Northwestern Indiana Regional Planning Commission.

- 1 (4) One (1) individual who is not a legislator, appointed by the
- 2 Michiana Area Council of Governments.
- 3 (d) The president pro tempore of the senate shall select one (1)
- 4 member of the commission to serve as the chairperson, **and one (1)**
- 5 **member of the commission to serve as the vice chairperson.**
- 6 (e) The commission shall study the following issues:
- 7 (1) The feasibility of establishing improvements to commuter
- 8 transportation and rail service in the Westlake County-Chicago
- 9 and Valparaiso-Chicago corridors.
- 10 (2) All aspects of regional mass transportation and road and
- 11 highway needs in Lake County, Porter County, LaPorte County,
- 12 St. Joseph County, and Elkhart County.
- 13 (3) The commission may study other topics as assigned by the
- 14 legislative council.
- 15 (f) The commission shall submit a final report of the commission's
- 16 findings and recommendations to the legislative council before
- 17 November 1, ~~1999~~: **2001**.
- 18 (g) Each member of the commission is entitled to receive the same
- 19 per diem, mileage, and travel allowances paid to individuals serving as
- 20 legislative or lay members on interim study committees established by
- 21 the legislative council.
- 22 (h) The legislative services agency shall provide staff support to the
- 23 commission.
- 24 (i) This SECTION expires November 2, ~~1999~~: **2001**.
