DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-12-23-60.

Synopsis: Funding of the Kinsey Institute. Provides that state appropriations may not be used for the administration, operation, and programs of the Kinsey Institute for Research in Sex, Gender, and Reproduction. Provides that political subdivisions may not appropriate money for the Kinsey Institute.

Effective: July 1, 1999.

HOUSE BILL No. 1862

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 20-12-23-60 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 1999]: **Sec. 60. (a) For purposes of this**
4 **section, "administration, operation, and programs" includes any**
5 **of the following that are used or done for, by, or on behalf of the**
6 **Kinsey Institute for Research in Sex, Gender, and Reproduction:**
7 (1) **On-campus facilities.**
8 (2) **Equipment, furniture, furnishings, or office supplies.**
9 (3) **Land or property.**
10 (4) **Utilities.**
11 (5) **Advertising or promotional material included in literature**
12 **or media presentations.**
13 (6) **Loans, grants, special accounts, or funds.**
14 (7) **Programs, special projects, or research.**
15 (8) **Maintenance of facilities.**
16 (9) **Administrative costs, operational costs, rentals, or**
17 **mortgages.**
