## DIGEST OF INTRODUCED BILL

**Citations Affected:** None (noncode).

**Synopsis:** Build Indiana fund appropriations. Makes the following appropriations from the build Indiana fund: (1) \$25,000 to the Washington Township fire department in Morgan County; (2) \$25,000 to the Nineveh volunteer fire department in Johnson County; (3) \$50,000 to the town of Bargersville; and (4) \$50,000 to the Clay Township fire department in Morgan County.

A BILL FOR AN ACT concerning state offices and administration and to make an appropriation.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. [EFFECTIVE JULY 1, 1999] (a) There is  
2 appropriated to the Washington Township fire department in  
3 Morgan County twenty-five thousand dollars (\$25,000) from the  
4 build Indiana fund established under IC 4-30-17 for a fire truck  
5 beginning July 1, 1999, and ending June 30, 2001.

6 (b) This SECTION expires December 31, 2001.

7 SECTION 2. [EFFECTIVE JULY 1, 1999] (a) There is  
8 appropriated to the Nineveh volunteer fire department in Johnson  
9 County twenty-five thousand dollars (\$25,000) from the build  
10 Indiana fund established under IC 4-30-17 for a fire truck  
11 beginning July 1, 1999, and ending June 30, 2001.

12 (b) This SECTION expires December 31, 2001.

13 SECTION 3. [EFFECTIVE JULY 1, 1999] (a) There is  
14 appropriated to the town of Bargersville fifty thousand dollars  
15 (\$50,000) from the build Indiana fund established under IC 4-30-17  
16 for the construction of a town hall beginning July 1, 1999, and  
17 ending June 30, 2001.
