

SENATE MOTION

MR. PRESIDENT:

I move that Senate Bill 263 be amended to read as follows:

- 1 Page 1, line 3, delete "Notwithstanding" and insert "**Except as**
2 **provided in subsection (c), notwithstanding**".
- 3 Page 1, between lines 10 and 11, begin a new paragraph and insert:
4 "**(c) The division may not grant specific approval to be a new**
5 **provider of one (1) or more of the drugs listed under subsection (b)**
6 **unless:**
- 7 **(1) the drugs will be provided in a county with a population of**
8 **more than forty thousand (40,000);**
- 9 **(2) there are no other providers located in the county or in a**
10 **county contiguous to the county where the provider will**
11 **provide the drugs; and**
- 12 **(3) the provider supplies, in writing:**
- 13 **(A) a needs assessment for Indiana citizens under**
14 **guidelines established by the division; and**
- 15 **(B) any other information required by the division."**
- 16 Page 1, line 11, delete "(c) The" and insert "**(d) Except as provided**
17 **in subsection (k), the**".
- 18 Page 2, between lines 10 and 11, begin a new line block indented
19 and insert:
- 20 **"(9) Patient information as reported to a central registry**
21 **created by the division."**
- 22 Page 2, line 11, delete "(d)" and insert "**(e)**".
- 23 Page 2, line 13, delete "(c)" and insert "**(d)**".
- 24 Page 2, between lines 14 and 15, begin a new paragraph and insert:
25 "**(f) The information provided to the division under subsection**
26 **(e) must be based on a calendar year.**
- 27 **(g) The information required under subsection (e) for calendar**
28 **year 1998 must be submitted to the division not later than June 30,**
29 **1999. Subsequent information must be submitted to the division**
30 **not later than:**
- 31 **(1) February 28, 2000, for calendar year 1999; and**
32 **(2) February 28, 2001, for calendar year 2000.**
- 33 **(h) Failure of a certified provider to submit the information**

- 1 required under subsection (e) may result in suspension or
- 2 termination of the provider's certification.
- 3 (i) The division shall report to the governor and the legislative
- 4 council the failure of a certified provider to provide information
- 5 required by subsection (e).".
- 6 Page 2, line 15, delete "(e)" and insert "(j)".
- 7 Page 2, line 16, delete "(c)" and insert "(d)".
- 8 Page 2, between lines 16 and 17, begin a new paragraph and insert:
- 9 "(k) The first report the division is required to prepare under
- 10 subsection (d) is due not later than September 30, 1999.
- 11 (l) The division shall establish a central registry to receive the
- 12 information required by subsection (d)(9).".
- 13 Page 2, line 17, delete "(f)" and insert "(m)".
