

SENATE MOTION

MR. PRESIDENT:

I move that Senate Bill 293 be amended to read as follows:

- 1 Page 7, line 20, delete "continuous" and insert "**continual**".
- 2 Page 7, line 28, delete "provides" and insert "**must provide**".
- 3 Page 13, line 12, delete "and".
- 4 Page 13, line 13, after "Employees" insert ", **and Volunteers**".
- 5 Page 13, line 31, after "employee" insert "**or a volunteer**".
- 6 Page 13, line 32, after "employee's" insert "**or volunteer's**".
- 7 Page 13, line 34, after "individual" insert "**or allow a volunteer**".
- 8 Page 13, line 36, after "individual's" insert "**or volunteer's**".
- 9 Page 13, line 39, after "individual" insert "**or allow a volunteer**".
- 10 Page 13, line 40, after "individual's" insert "**or volunteer's**".
- 11 Page 13, line 41, after "individual" insert "**or volunteer**".
- 12 Page 14, line 10, after "individual" insert "**or allow a volunteer**".
- 13 Page 14, line 12, after "individual's" insert "**or volunteer's**".
- 14 Page 14, line 15, after "individual's" insert "**or volunteer's**".
- 15 Page 14, line 21, before "A" insert "**This subsection does not apply**
- 16 **to a hospice program volunteer.**".
- 17 Page 15, line 2, delete "." and insert ", **including the:**
- 18 (1) **types of nursing services;**
- 19 (2) **other services;**
- 20 (3) **services that are available upon request; and**
- 21 (4) **specific:**
- 22 (A) **time periods; and**
- 23 (B) **duration of availability;**
- 24 **during which each service will be provided.**".
- 25 Page 15, line 8, delete "if a hospice employee provides services or"
- 26 and insert "**a hospice employee may provide supplies to a:**
- 27 (1) **hospice program patient; or**
- 28 (2) **hospice program patient's family;**
- 29 **in addition to the supplies provided by the hospice program, but**
- 30 **the employee may only be reimbursed for the supplies by providing**
- 31 **a written receipt to the hospice program patient or the hospice**
- 32 **program patient's family.**".
- 33 Page 15, delete lines 9 through 16.

1 Page 15, line 18, delete "reports of problems" and insert
2 "complaints".

3 Page 15, between lines 20 and 21, begin a new paragraph and insert:

4 **"Sec. 3. The hospice services and plan of care to be provided to**
5 **the hospice program patient must be:**

6 (1) provided to; and

7 (2) approved by;

8 **the hospice program patient or the hospice program patient's**
9 **family."**
