

SENATE MOTION

MR. PRESIDENT:

I move that Engrossed House Bill 2043 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 5-10-8-1 IS AMENDED TO READ AS
4 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 1. The following
5 definitions apply in this chapter:
6 (1) "Employee" means:
7 (A) an elected or appointed officer or official, or a full-time
8 employee;
9 (B) if the individual is employed by a school corporation, a
10 full-time or part-time employee;
11 (C) for a local unit public employer, a full-time or part-time
12 employee or a person who provides personal services to the
13 unit under contract during the contract period; or
14 (D) a senior judge appointed under IC 33-2-1-8;
15 whose services have continued without interruption at least thirty
16 (30) days.
17 (2) "Group insurance" means any of the kinds of insurance
18 fulfilling the definitions and requirements of group insurance
19 contained in IC 27-1.
20 (3) "Insurance" means insurance upon or in relation to human life
21 in all its forms, including life insurance, health insurance,
22 disability insurance, accident insurance, hospitalization insurance,
23 surgery insurance, medical insurance, and supplemental medical
24 insurance.
25 (4) "Local unit" includes a city, town, county, township, or school
26 corporation.
27 (5) **"New traditional plan" means a self-insurance program**
28 **established under section 7(b) of this chapter to provide**
29 **health care coverage.**
30 (6) "Public employer" means the state or a local unit, including
31 any board, commission, department, division, authority,
32 institution, establishment, facility, or governmental unit under the
33 supervision of either, having a payroll in relation to persons it

- 1 immediately employs, even if it is not a separate taxing unit.
 2 ~~(6)~~ (7) "Public employer" does not include a state educational
 3 institution (as defined under IC 20-12-0.5-1).
 4 ~~(7)~~ (8) "Retired employee" means:
 5 (A) in the case of a public employer that participates in the
 6 public employees' retirement fund, a former employee who
 7 qualifies for a benefit under IC 5-10.3-8;
 8 (B) in the case of a public employer that participates in the
 9 teachers' retirement fund under IC 21-6.1, a former employee
 10 who qualifies for a benefit under IC 21-6.1-5; and
 11 (C) in the case of any other public employer, a former
 12 employee who meets the requirements established by the
 13 public employer for participation in a group insurance plan for
 14 retired employees.
 15 ~~(8)~~ (9) "Retirement date" means the date that the employee has
 16 chosen to receive retirement benefits from the employees'
 17 retirement fund."
 18 Page 1, line 3, delete "member of the general assembly" and insert
 19 **"state employee occupying a position that is eligible for coverage**
 20 **under the new traditional plan on June 30, 1999,"**.
 21 Page 1, line 11, delete "former member of the general assembly"
 22 and insert **"retired state employee who occupied a position that is**
 23 **eligible for coverage under the new traditional plan on June 30,**
 24 **1999, and"**.
 25 Page 1, line 13, delete "8(e)" and insert **"8"**.
 26 Page 2, line 3, delete "8(e)" and insert **"8"**.
 27 Page 2, line 3, delete "if the former member meets the" and insert
 28 **"."**.
 29 Page 2, delete line 4, begin a new paragraph and insert:
 30 **"(c) A state employee or retired state employee who chooses a**
 31 **plan described in subsection (a)(1) or (b)(1) shall pay any amount**
 32 **of both the employer and the employee share of the cost of the**
 33 **coverage that exceeds the cost of the coverage under the new**
 34 **traditional plan."**

- 2 indented.
- 3 Renumber all SECTIONS consecutively.
