MR. PRESIDENT:

I move that Engrossed House Bill 1904 be amended to read as follows:

- 2 Page 16, delete lines 19 through 21.
- 3 Page 16, line 22, delete "(8)" and insert "(7)".
- 4 Page 16, between lines 22 and 23, begin a new paragraph and insert:
- 5 **"(b) The board shall submit the school's biennial budget to the**
- 6 **department of education, which shall review the proposed budget.**
- 7 **As part of its review, the department may request and shall receive**
- 8 **from the board, in a form as may reasonably be required by the**
- 9 **department, all information used by the board to develop the**
- 10 **proposed budget. If, upon review, the department determines that**
- 11 **any part of the budget request is not supported by the information**
- 12 **provided, the department shall meet with the board at the earliest**
- 13 **date possible in order to reconcile the budget request. The**
