

SENATE MOTION

MR. PRESIDENT:

I move that Engrossed House Bill 1309 be amended to read as follows:

- 1 Page 3, between lines 34 and 35, begin a new paragraph and
 2 insert:
 3 "SECTION 3. IC 27-13-9-3 IS AMENDED TO READ AS
 4 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 3. (a) A health
 5 maintenance organization shall notify an enrollee in writing of the
 6 termination of:
 7 (1) the provider who currently provides primary health care
 8 services to that enrollee; **and**
 9 (2) **any other participating provider seen by the enrollee**
 10 **during the previous year.**
 11 (b) After the termination of the provider who provided primary
 12 health care services to an enrollee, the health maintenance organization
 13 shall assist the enrollee in transferring to another participating primary
 14 care provider."
 15 Page 11, between lines 21 and 22, begin a new paragraph and
 16 insert:
 17 "SECTION 8. IC 27-13-34-12 IS AMENDED TO READ AS
 18 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 12. A limited service
 19 health maintenance organization operated under this chapter is subject
 20 to the following:
 21 (1) IC 27-13-8, except for IC 27-13-8-2(a)(5) concerning reports.
 22 (2) **IC 27-13-9-3 concerning termination of providers.**
 23 (3) IC 27-13-10-1 through IC 27-13-10-3 concerning grievance
 24 procedures.
 25 ~~(3)~~ (4) IC 27-13-11 concerning investments.
 26 ~~(4)~~ (5) IC 27-13-15-1(a)(2) through IC 27-13-15-1(a)(3)
 27 concerning gag clauses in contracts.
 28 ~~(5)~~ (6) IC 27-13-21 concerning producers.
 29 ~~(6)~~ (7) IC 27-13-29 concerning statutory construction and
 30 relationship to other laws.
 31 ~~(7)~~ (8) IC 27-13-30 concerning public records.
 32 ~~(8)~~ (9) IC 27-13-31 concerning confidentiality of medical

2 ~~(9)~~ **(10)** IC 27-13-36-5 and IC 27-13-36-6 concerning referrals
3 to out of network providers and continuation of care.
4 ~~(10)~~ **(11)** IC 27-13-40 concerning comparison sheets of services
5 provided by the limited service health maintenance organization.
6 Renumber all SECTIONS consecutively.
