## SENATE BILL No. 66

DIGEST OF SB 66 (Updated February 1, 1999 6:00 p.m.) - DI KCC)

**Citations Affected:** IC 13-23.

**Synopsis:** Underground storage tank penalties. Provides that a person is not subject to the civil penalty for violation of an underground storage tank standard if: (1) the tank is on a brownfield; (2) the person was not the owner or operator of the facility when the violation first occurred; and (3) the site is brought into compliance within one year after the person acquired the property.

**Effective:** July 1, 1999.

## SENATE BILL No. 66

A BILL FOR AN ACT to amend the Indiana Code concerning underground storage tanks.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 13-23-14-3 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 1999]: Sec. 3. **(a) Except as**  
3 **provided in subsection (b)**, a person who violates:  
4 (1) a requirement or standard set forth in this article; or  
5 (2) a rule adopted under IC 13-23-1-2 other than a violation  
6 described in section 2 of this chapter;  
7 is subject to a civil penalty of not more than ten thousand dollars  
8 (\$10,000) per underground storage tank for each day of violation.  
9 **(b) A person is not subject to the civil penalty described in**  
10 **subsection (a) if:**  
11 **(1) the violation arose from a tank that is on a brownfield;**  
12 **(2) the person was not the owner or operator of the facility**  
13 **when the violation first occurred; and**  
14 **(3) the site is brought into compliance with this article not**  
15 **later than one (1) year after the person acquired ownership of**  
16 **the property.**
