DIGEST OF SB0199 (Updated February 18, 1999 2:49 pm - DI 44)

Citations Affected: None (noncode).

Synopsis: Appropriation to local road and street account. Appropriates \$100,000,000 per year for each year of the biennium from the state general fund to the local road and street account. Provides that the appropriation is to be transferred from the state general fund to the local road and street account in monthly installments.

Effective: July 1, 1999.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1998 General Assembly.

SENATE BILL No. 199

A BILL FOR AN ACT concerning the local road and street account and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE JULY 1, 1999] (a) **On the twenty-fifth**
2 **day of each month, beginning July 25, 1999, and ending June 25,**
3 **2001, the auditor of state shall transfer eight million three hundred**
4 **thirty-three thousand three hundred thirty-three dollars**
5 **(\$8,333,333) from the state general fund to the local road and street**
6 **account established by IC 8-14-2-4. The transfers required under**
7 **this SECTION are annually appropriated from the state general**
8 **fund.**
9 (b) **This SECTION expires July 1, 2001.**
