SENATE BILL No. 262

DIGEST OF SB 262 (Updated February 17, 1999 1:33 pm - DI 51)

Citations Affected: IC 16-18; IC 16-36.

Synopsis: Out of hospital do not resuscitate orders. Provides for use of do not resuscitate orders for certain patients in locations other than acute care hospitals. Allows a patient with a terminal condition or a patient with a medical condition that would ultimately prevent cardiopulmonary resuscitation efforts from being successful to express the patient's wish that cardiopulmonary resuscitation not be undertaken if the patient's cardiac or pulmonary functions cease at a location other than an acute care hospital. Provides for revocation of an "out of hospital do not resuscitate declaration and order". Provides guidance and immunity for health care providers in caring for a patient with an executed "out of hospital do not resuscitate declaration and order". Establishes criminal penalties.

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 16-18-2-29 IS AMENDED TO READ AS

3 physician" means the licensed physician who has the primary

 14 (2) endotracheal intubation and other advanced airway
 15 management;
 16 (3) artificial ventilation;
 17 (4) defibrillation;
 18 (5) administration of cardiac resuscitation medications; and
 19 (6) related procedures.

20 The term does not include the Heimlich maneuver or a similar
 21 procedure used to expel an obstruction from the throat.

22 **Sec. 2. As used in this chapter, "competent witness" means a**
 23 **person at least eighteen (18) years of age who is not:**

- 24 (1) the person who signed an out of hospital DNR declaration
 25 on behalf of and at the direction of the declarant;
 26 (2) a parent, spouse, or child of the declarant;
 27 (3) entitled to any part of the declarant's estate; or
 28 (4) directly financially responsible for the declarant's medical
 29 care.

30 For purposes of subdivision (3), a person is not considered to be
 31 entitled to any part of the declarant's estate solely by virtue of
 32 being nominated as a personal representative or as the attorney for
 33 the estate in the declarant's will.

34 **Sec. 3. As used in this chapter, "declarant" means a person:**

- 35 (1) who has executed an out of hospital DNR declaration
 36 under section 11(a) of this chapter; or
 37 (2) for whom a representative has executed an out of hospital
 38 DNR declaration under section 11(b) of this chapter;

39 and for whom an out of hospital DNR order has been written
 40 under section 12 of this chapter.

41 **Sec. 4. As used in this chapter, "DNR" means do not resuscitate.**

42 **Sec. 5. As used in this chapter, "out of hospital" refers to a**

8 medical services commission under section 17 of this chapter.

9 Sec. 8. As used in this chapter, "qualified person" means an
10 individual certified as a qualified person under section 10 of this

12 Sec. 9. As used in this chapter, "representative" means a
13 person's:

- 14 (1) legal guardian or other court appointed representative
15 responsible for making health care decisions for the person;
- 16 (2) health care representative under IC 16-36-1; or

19 Sec. 10. An attending physician may certify that a patient is a
20 qualified person if the attending physician determines, in
21 accordance with reasonable medical standards, that one (1) of the

24 IC 16-36-4-5).
- 25 (2) The person has a medical condition such that, if the person
26 were to suffer cardiac or pulmonary failure, resuscitation
27 would be unsuccessful or within a short period the person
28 would experience repeated cardiac or pulmonary failure
29 resulting in death.

30 Sec. 11. (a) A person who is of sound mind and at least eighteen
31 (18) years of age may execute an out of hospital DNR declaration.

32 (b) A person's representative may execute an out of hospital
33 DNR declaration for the person under this chapter only if the
34 person is:

- 35 (1) at least eighteen (18) years of age; and
- 36 (2) incompetent.

37 (c) An out of hospital DNR declaration must meet the following
38 conditions:

- 39 (1) Be voluntary.

- 41 (3) Be signed by the person making the declaration or by

8 **(1) may be issued only by the declarant's attending physician;**
9 **and**

10 **(2) may be issued only if both of the following apply:**

11 **(A) The attending physician has determined the patient is**
12 **a qualified person.**

13 **(B) The patient has executed an out of hospital DNR**
14 **declaration under section 11 of this chapter.**

15 **Sec. 13. (a) An attending physician who does not issue an out of**
16 **hospital DNR order for a patient who is a qualified person may**
17 **transfer the patient to another physician, who may issue an out of**
18 **hospital DNR order, unless:**

19 **(1) the attending physician has reason to believe the patient's**
20 **declaration was not validly executed, or there is evidence the**
21 **patient no longer intends the declaration to be enforced; and**

22 **(2) the patient is unable to validate the declaration.**

23 **(b) Notwithstanding section 10 of this chapter, if an attending**
24 **physician, after reasonable investigation, does not find any other**
25 **physician willing to honor the patient's out of hospital DNR**
26 **declaration and issue an out of hospital DNR order, the attending**
27 **physician may refuse to issue an out of hospital DNR order.**

28 **(c) If the attending physician does not transfer a patient under**
29 **subsection (a), the attending physician may attempt to ascertain**
30 **the patient's intent and attempt to determine the validity of the**
31 **declaration by consulting with any of the following individuals who**
32 **are reasonably available, willing, and competent to act:**

33 **(1) A court appointed guardian of the patient, if one has been**
34 **appointed. This subdivision does not require the appointment**
35 **of a guardian so that a treatment decision may be made under**
36 **this section.**

37 **(2) A person designated by the patient in writing to make a**
38 **treatment decision.**

39 **(3) The patient's spouse.**

40 **(4) An adult child of the patient or a majority of any adult**
41 **children of the patient who are reasonably available for**
42 **consultation.**

condition such that, if I suffer cardiac or pulmonary failure, resuscitation would be unsuccessful or within a short period I would experience repeated cardiac or pulmonary failure resulting in death.

I direct that, if I experience cardiac or pulmonary failure in a location other than an acute care hospital, cardiopulmonary resuscitation procedures be withheld or withdrawn and that I be permitted to die naturally. My medical care may include any medical procedure necessary to provide me with comfort care or to alleviate pain.

I understand that I may revoke this out of hospital DNR declaration at any time by a signed and dated writing, by destroying or canceling this document, or by communicating to health care providers at the scene the desire to revoke this declaration.

I understand the full import of this declaration.

 25 is incompetent.
 26 (c) A revocation is effective upon communication to a health
 27 care provider.
 28 (d) A health care provider to whom the revocation of an out of
 29 hospital DNR declaration and order is communicated shall
 30 immediately notify the declarant's attending physician, if known,

4 **decision to withhold or withdraw CPR, an out of hospital DNR**

8 **presume in the absence of actual notice to the contrary that the**
9 **declarant was of sound mind when the out of hospital DNR**
10 **declaration and order was executed.**

11 **(c) The fact that a declarant executed an out of hospital**
12 **declaration may not be considered as an indication of the**
13 **declarant's mental incompetency.**

14 **Sec. 22. (a) A person may challenge the validity of an out of**
15 **hospital DNR declaration and order by filing a petition for review**
16 **in a court in the county in which the declarant resides.**

17 **(b) A petition filed under subsection (a) must include the name**
18 **and address of the declarant's attending physician.**

19 **(c) A court in which a petition is filed under subsection (a) may**
20 **declare an out of hospital DNR declaration and order void if the**

(d) An out of hospital DNR declaration and order may not be considered in the establishment of insurance premiums for a declarant.

(e) A person may not require another person to execute an out of hospital DNR declaration and order as a condition for being insured for or receiving health care services.

(f) This chapter does not impair or supersede any legal right or legal responsibility that a person may have to effect the withholding or withdrawal of CPR in a lawful manner.

Sec. 24. This chapter does not create any presumption concerning the intent of a person who has not executed an out of hospital DNR declaration and order to consent to the withholding or withdrawal of CPR if a terminal condition exists, or if a medical condition exists such that the outcome of performing CPR would have the results specified in section 10(2) of this chapter.

Sec. 25. This chapter does not authorize euthanasia or any affirmative or deliberate act or omission to end life other than to permit the natural process of dying.

Sec. 26. The act of withholding or withdrawing CPR, when done under:

- (1) an out of hospital DNR declaration and order issued under this chapter;
- (2) a court order or decision of a court appointed guardian; or
- (3) a good faith medical decision by the attending physician that the patient has a terminal illness;

is not an intervening force and does not affect the chain of proximate cause between the conduct of a person that placed the patient in a terminal condition and the patient's death.

Sec. 27. A person who knowingly or intentionally:

- (1) physically cancels or destroys an out of hospital DNR declaration and order without the declarant's consent;
- (2) physically cancels or destroys an out of hospital DNR declaration and order without the declarant's representative's consent if the declarant is incompetent; or
- (3) falsifies or forges a revocation of another person's out of hospital DNR declaration and order;

commits a Class B misdemeanor.

Sec. 28. (a) A person who knowingly or intentionally:

- (1) falsifies or forges the out of hospital DNR declaration and order of another person with intent to cause the withholding or withdrawal of CPR; or
